Ñan armij ro rej reen im edik aer jāān im rej bōk jibañ ikijen kōllā reen jāān kien, alap ro rej aikuj in lelak **30 raan in kōjjelā** ilo jeje mōkta jāān an file juon jolok ilo jikin ekkajet im ej pedped ion jab kōllā onean reen (ej maroñ in walok ke 30 raan in kōjjelā in ej maroñ in jerbal ñan kōjjelā ko jot ikijen kabōjrak ako jolok bar āinwot, ako kakien eo ejjab lukkun kwalok kake menin).
