Ekkewe chon rent mi or ar pwung ar repwe ekeunoi ewe eviction ika pwe re menatiw ar kewe niwinimang ngeni ewe soufenu ren ar rent, fees, ika ekkewe utilities ese pwan nifinifin inet atun nge epwe chok tori atun aa wesino ewe eviction trial. Ekkewe soufenu eseor ar pwung ar resapw angei ika etiwa ewe late payment, ika mwo aa fen nuseni ewe twinin maramen ewe nonpayment esinesin.

### Inet atun ekkewe chon rent repwe menatiw?
